

## Slightly alkaline industrial floor cleaner for the cleaning with auto-scrubbers

### Description

OBTEGO® C-105 is a slightly alkaline, solvent-free cleaner concentrate for industrial floors with an optimal tuned combination of various cleaning components and is especially suitable for the application with auto-scrubbers.

### Properties

OBTEGO® C-105 dissolves and removes slightly oil and grease soiling, abrasion from rubber, and general soiling.

### Application Range

For cleaning of all kinds of alkaline- and water-resistant industrial floors with auto-scrubbers or ride on machines. Ideally suitable for the maintenance cleaning of stressed soiled areas.

### Processing

In dependence of the kind and intensity of the soiling, dilute OBTEGO® C-105 from 1:50 to 1:200 with water and use it with an auto-scrubber.

### Productiveness

In dependence of soiling and surface, approx. 1.000 – 4.000 m<sup>2</sup>/liter.

### Storage

Shelf-life in cool and closed container is about 24 months.

### Environmental Protection

All contained surfactants are biodegradable up to 98% (OECD method). The product is free of preservatives and fragrances. WGK 1 (weakly water-polluting).

Waste codes/waste designations according to EWC/AVV. 20 01 29\* municipal wastes: Detergents containing dangerous substances. (\*Evidence for disposal must be provided.) Dispose of waste according to applicable legislation. Completely emptied packages can be recycled. Empty containers are recyclable and can be disposed to a reusable material collection system.

### Safety

Ingredients: Ethoxylated alcohol C9-C11, Ethoxylated fatty alcohol. < 5% non-ionic surfactants.
